Request

I request information on how my personal data are processed within the Swedish Police Authority in the following field of activities.

- ☐ Crime investigations - report of an offence, coercive measures, etc
(information in ongoing cases is often covered by confidentiality and will not be disclosed)
- ☐ Intelligence (the information is almost always covered by confidentiality and will not be disclosed)
- ☐ Traffic - automatic traffic security controls, wanted vehicles, etc
- ☐ Border activities/activities involving foreigners (the information is often covered by confidentiality and will not be disclosed)
- ☐ International police activities
- ☐ Activities at communication centers
- ☐ Animals struck by vehicles
- ☐ Forensic activities - DNA, signalements, fingerprints, etc
- ☐ Collection of taxes and judgments - payment of fines, court fines, penal etc. (not parking notes)
- ☐ Lost properties, animals, service of process and parking notes
- ☐ Permits
- ☐ Weapons
- ☐ Supervision - security guards and other appointments
- ☐ Identity documents - passports and national identity cards
- ☐ Matters in public records - damages, requests for public documents, etc
- ☐ Digital archives
- ☐ Staff administration - if you are or have been employed by the Police Authority
- ☐ Recruitments - applications for positions within the Police Authority
- ☐ Economic activities - suppliers, invoice processing, etc
- ☐ Internal investigations - complaints against Police Authority employees
- ☐ Other, enter case number (e.g. K-no., HR-no., or A-no.)

Your information will be preserved or deleted in accordance with applicable archiving legislation at any time and may be provided in accordance with the principle of public access to information.
