The personal data you provide in an application is processed as part of our exercise of authority and to carry out the tasks stipulated in the Public Order Act (1993:1617) and in local provisions. The purpose of the processing is to manage your application. The data is saved for the time being.

Documents submitted to the Swedish Police Authority are generally regarded as public documents which are registered and saved pursuant to the Public Access to Information and Secrecy Act (2009:400) and archiving legislation. If someone requests access to a public document, the information may therefore be disclosed in accordance with the principle of public access to official documents.
