**Information about personal data processing in connection with your notification**

When receiving notification of registration of trade in second-hand goods, the Swedish Police Authority processes the personal data submitted in e-services, forms and online forms on polisen.se in accordance with the provisions of the EU General Data Protection Regulation and other applicable data protection regulations. The personal data provided in the notification is processed in order to meet a legal obligation under the Act on trade in second-hand goods (1999:271). The purpose of this processing is to prevent the sale of stolen or otherwise unlawfully acquired goods and to help the Swedish Police Authority in its search for such goods. Data is saved indefinitely.

As a rule, documents submitted to the Swedish Police Authority are regarded as official documents and stored in accordance with the Public Access to Information and Secrecy Act (2009:400) and archiving legislation. If someone requests access to an official document, the information may therefore be disclosed in accordance with the principle of public access to official documents, unless they are subject to secrecy.
